4. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Friday 12 April 2019. Applications can be made online: <https://www.gov.uk/register-to-vote>.
5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Parkside, Chart Way, Horsham, RH12 1RL by 5 pm on Monday, 15th April 2019.
6. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Parkside, Chart Way, Horsham, RH12 1RL by 5 pm on Wednesday, 24th April 2019.
7. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Parkside, Chart Way, Horsham, RH12 1RL by 5 pm on Thursday, 2nd May 2019. The physical incapacity must have occurred after 5 pm on Wednesday, 24th April 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5 pm on Wednesday, 24th April 2019
