1. Apologies for Absence.

Apologies were received and accepted from Cllr Knight.

3. Planning matters

4. Joint Parishes Youth Committee

Cllr Russell noted that the service provided by Horsham Matters and the Youth Worker, had been excellent.

The Council was concerned over the cost of the service to the Parish Council, given the lack of uptake of the service by children in the Parish. It was therefore **RESOLVED** that the Council would not enter into a further contract with Horsham Matters for 2018/19, and would cease to be a member of the Joint Parishes Youth Committee (JPYC). However, the Council agreed that it would like to make a grant of £1,000 towards the service in the year 2018/19, which would be on the understanding that this contributes towards youth services in the Ashurst/Steyning area.
