## MINUTES OF THE MEETING HELD AT THE ASHURST VILLAGE HALL ON THURSDAY 3<sup>rd</sup> NOVEMBER 2016 AT 8.00PM

#### 1. Apologies for Absence.

Apologies were received from Cllr Hammond, Cllr Barling (West Sussex County Council) and from Cllrs Lloyd and Willett (both Horsham District Council).

#### 2. Declaration of Members Interest.

None for this meeting.

### 3. Approve the Minutes of the Meetings of 1<sup>st</sup> September 2016 and extraordinary meeting of 6<sup>th</sup> October 2016.

The minutes of the meeting of 1<sup>st</sup> September 2016 and extraordinary meeting of 6<sup>th</sup> October 2016 were circulated to all cllrs and taken as read. It was **RESOLVED** that both sets of minutes be approved and adopted as a true record of the meetings and they were signed by the Chairman.

#### **Outstanding Actions.**

- The Winter Maintenance Plan has been submitted to Horsham District Council and published on the website for the parish council.
- The Council now receive email updates from Sussex Neighbourhood Alert
- The Clerk has, for a second time, reported the potholes on both sides of the Ashurst to Partridge Green Rd between the village hall and Golden Lane, as well as potholes on the B2315 on the North bound side, at the bottom of Hills Farm and between the junction of Honeybridge Lane and Church Lane - these were repaired but are now breaking up.
- Cllr Lloyd's email update on Priors Byne Solar Farm was read out the agreement was in fact with Highways at WSCC for the developer to make good the roads.
- The bund at Soper's Farm Chairman to speak to Cllr Willett directly.

#### **ACTIONS**

- Clerk to report the 1m<sup>2</sup> pothole on the B2315, just north of Hills Farm to West Sussex County Council;
- Clerk to ask West Sussex County Council to look at the before and after photographs / footage of the roads around Prior's Byne Solar Farm, to see if the developer was responsible for damage to the highways;
- 3. Clerk to ask Cllr Willett to find out of there is anything on file at Horsham District Council regarding the bund at Soper's Farm. Find out of Cllr Willett can attend the next meeting of Ashurst Parish Council;
- 4. Cllr Hedley to ask Alan Griffiths to attend next meeting of Ashurst Parish Council.

It was **RESOLVED** that the salary that the clerk receives for her work as Clerk to Ashurst Recreation Ground Trust be paid by Ashurst Parish Council rather than the Recreation Ground Trust.

It was **AGREED** that the Annual Recreation Ground Meeting be held on the first Thursday of September from 2017, on the same night as a Parish Council meeting as this annual meeting takes less than half an hour.

#### 5. Planning Matters.

5.1 **DC/16/2140** – Proposed glass house at Gratwicks House Church Lane Ashurst, BN44 3AR.

No objection.

- 5.2 DC/16/2164 Proposed replacement of a sand-school with a tennis court and cricket practice strip within garden area at Gratwicks House Church Lane Ashurst, BN44 3AR. Objection: The Council expressed a strong objection due to the proposed flood lighting at 10m tall, being out of keeping in rural area and causing light pollution. In addition, they were concerned over the proximity of the area to the school and asked Horsham District Council planning to consider asking for the work to be carried out in the school holidays to avoid distraction of the pupils and, more importantly, for the safety of the children on the road.
- 5.3 **DC/16/2225** Single storey side extension. Replacement of all existing tile hanging with cladding/weather boarding at Spithandle, Spithandle Lane, Wiston, Steyning, BN44 3DY. **No objection.**

Cllrs expressed their concern over the frequency of cycle races on racing bikes on the country roads in the Parish, in particular on School Lane.

#### **Hedge on Pepper's Lane**

The hedge where Soper's Farm meets Pepper's Lane has become very overgrown and forces traffic to the other side of the road.

- Clerk to report the concerns over the cyclists to the appropriate body;
- Clerk to report the overgrown hedge to Highways.

#### 17. Clerk's contract

## Due to the confidential nature of the business discussed the press and public were requested to leave the meeting.

The updated contract was **AGREED** by Cllrs and signed by the Clerk and Cllr Hedley. The changes agreed reflected the Recreation Ground salary being paid directly by Ashurst Parish Council, an agreement on overtime payments and that the Clerk would receive a pay rise of one SCP on completion of the Certificate in Local Council Administration.

#### Appendix 1 – Report from Tree Warden

I have not been asked to write a report this year for the Recreation Ground, but have decided to to write a more general report covering various points.

1) Apologies to Councillors for not making them aware of safety issues resulting in the removal of a large clump of suckered Poplar on the verge of Church Lane, alongside Gratwicks.

This was identified as a hazardous after one of the trunks cracked off and fell through the boundary hedge onto the meadow behind. After much effort, UK Power Networks eventually put pressure on HDC to authorise and finance the total removal of the remaining suckers. This necessitated closure of Church Lane in May for a short time.

I will endeavour to keep the Parish Council better informed about any such issues I am involved with or hear about in future. However we should all remain vigilant and concerned as and when we see major tree work being carried out in the Parish.

2)RE the Recreation Ground, recommended works were carried out effectively last year. This year more good remedial work was carried out which did not involve me.

With reference to the tree I failed to identify last year, I can confirm it is a Wild Service Tree which has been planted as a standard and is doing well.

I can only add that there are still a few dead branches overhanging the mowing line to the South and East borders. However they appear to be low risk and will most likely come down during a storm.

- 3) Ash trees along Church Lane are now affected by Ash Die-back (Chalara virus) which is now so widespread it does not need to be reported to the Forestry Commission. In so far as these trees are overhanging the road they should be monitored. One is in the churchyard and several others are in the hedge line of Glebe Meadows.
- 4) Either side of the entrances to Glebe Meadows and Glebe Woods there are very large oaks in dieback and it looks like remedial work will be needed soon to branches overhanging the road. Given the wildlife value of standing dead wood it is hoped they can be carefully lopped rather than removed.
